

**120 NGOs FROM 49 COUNTRIES EXPRESS SUPPORT FOR COSTA RICA'S FORTHCOMING
RESOLUTION ON THE SOCIAL REINTEGRATION OF PERSONS RELEASED
FROM DETENTION OR UNDER NON-CUSTODIAL MEASURES**

September 6, 2024

To Permanent Representatives of Member and Observer States of the United Nations (Geneva, Switzerland):

We, the undersigned non-governmental organizations (NGOs) representing every region of the world, write to express our strong support for the circulating resolution led by Costa Rica, alongside the Core Group of The Gambia, Kazakhstan, Montenegro, and Romania, to be presented at the 57th session of the United Nations Human Rights Council (The Council). This resolution concerns the importance of treating the social reintegration of persons released from detention or under non-custodial measures as a human rights issue. We urge Governments to co-sponsor the important resolution.

All States face the challenges of ensuring successful social reintegration of convicted persons and preventing recidivism; yet, post-release support falls disproportionately on NGOs and families. Today, there are more than 11.5 million people behind bars around the world, or under other forms of criminal justice detention, and nearly all stand to be released and rejoin society. Additionally, there are millions more under non-custodial measures and actively living in the community. Specific groups of people convicted of a crime, such as women, children, racial, ethnic, or religious minorities, indigenous populations, the LGBTQ community, and people with disabilities, mental health challenges, or drug dependency, face special barriers to successful reintegration that must be holistically addressed.

We applaud emerging practices by UN Member States to advance re-entry and post-release support. Effective practices, such as medical care handoffs, housing assistance, connection to employment, family reunification, victim-offender dialogue, and public awareness campaigns, have significant benefits not only for reintegrating persons, but for the sustainable development of communities overall. Conversely, failed reintegration undermines the human rights of persons convicted of a crime, their families, and the broader community.

Rule 90 of the Nelson Mandela Rules emphasizes that “the duty of society does not end with a prisoner’s release,” and the UN System Common Position on Incarceration explains, “[e]ven the best prison-based rehabilitation progra[ms] will be undermined if former prisoners find themselves without any post-release support.” There is clear global consensus on the importance of support outside of prison facilities, yet existing international human rights frameworks do not provide guidance to States on how to implement transitional and community-based social reintegration programs. While the UN Office on Drugs and Crime has undertaken complementary efforts on social reintegration as a crime prevention strategy, further work is needed to advance this issue as a matter of human rights.

We welcome recent efforts by the Council in advancing first-ever dialogue on this human rights issue. In its 53rd session, the Council adopted resolution 53/27 regarding the prevention of

violence against women and girls in criminal justice detention. This resolution called on States to design and implement pre- and post-release programming to support the social reintegration of formerly incarcerated women and girls into the community. Then, in the 54th session, the Permanent Mission of Costa Rica presented the views of 74 countries from every region of the world, affirming social reintegration as a human rights issue and calling for the broader inclusion of all reintegrating persons in the implementation of pre- and post-release programming. The Joint Statement paves the way for the creation of guiding principles on social reintegration, and we strongly support this next step for the protection of human rights globally.

As NGOs, we recognize that social reintegration requires a collective global, national, and local commitment to creating strategies, sharing effective practices, and fostering collaboration. We recognize the important role the Council can play in advancing a global consensus on this issue, while also guiding States on the implementation of guiding principles that uphold the human rights and dignity of convicted persons.

We respectfully request your Government support Costa Rica's resolution.
